



## Memorandum of Understanding

This Memorandum of Understanding is executed at Kolkata on the 3rd May, 2024

BETWEEN

ICFAI University, Sikkim, hereinafter called the “Party One” (which expression shall unless it be repugnant to the context or meaning thereof mean and include its administrators, legal representatives and assigns) of the One part.

AND

Mental Care India - an Initiative by Upacharya Caregiving Services Pvt. Ltd., having its place of business at Greenfield City, BL-27, FL-8C, E3-398 Joth Sibrapur, Kolkata – 700141; INDIA hereinafter called the “Party Two” (which expression shall unless it be repugnant to the context or meaning thereof mean and include its administrators, legal representatives and assigns) of the Second part.

WHEREAS:

1. **Party Two** has approached **Party One** to provide Positive Mental Health and Wellbeing sessions to the students of Party One.
2. A total of 4 sessions will be conducted in a year along with an additional Teacher Navigation Program.
3. The sessions will be conducted by Counsellors and Wellbeing Coaches from different parts of the country and certificates will be provided to the attendees.
4. An annual fee of INR 1000 per student will be charged for providing the services.
