- INDGenius in cooperation with The ICFAI University, Sikkim seek to undertake the following events/activities: -
 - a) Organize interactive group discussions or Sewa activities on campus as well as off campus.
 - b) Organize debates and talks on issues of national and international importance pertaining to social, economic, developmental concern.
 - c) To facilitate guests (real life role model) to deliver lectures on issues concerning the society at large.
 - d) Organize and provide Fellowship/internship programs with various *Sewa* organizations, think tanks, public policy organisations, and bureaucrats.
 - e) Organize flagship Conferences, Workshops, Seminars, Keynote lectures and Mentorship sessions including the one's on days of National importance.
 - f) To encourage participation of the students and faculty members in social cum academic activities which concerns today's society.
 - g) To form a Study Circle to discuss the issues among students and faculties on current topics which affect the society as well as to invite any eminent guest speaker.
 - h) Adoption of a village near institution to spread awareness through organizing medical camp and adopting tree plantation activity and similar social activities.
 - i) Creating a public policy club, regional cultural research centre and other domainoriented clubs/centre in the institute as agreed upon.
 - j) To work towards promoting implementation of National Education Policy 2020 in the institute and facilitate lectures regarding same.
 - k) To mentor students aspiring to pursue graduation abroad through various workshops, mentor-mentee initiatives and application guidance.

- To collaborate for the annual fest of the University and other events and facilitate in terms of resource-person as and when required.
- m) To jointly organize Flag Parade on the Republic Day and Independence Day in the Campus to promote the spirit of nationalism amongst the students.
- n) To jointly work together towards CV enhancement and creation of opportunities for students in the University.
- o) To organize Official Y20 and Civil 20 Activities in the Campus
- 4. The ICFAI University, Sikkim shall make every endeavour to provide assistance, infrastructural facilities and cooperation for the successful implementation of the events and activities and shall do the followings: -
 - a) Allow and permit INDGenius to organize the events/activities in campus and off campus.
 - b) Allow and permit representatives of INDGenius to attend and participate in the seminars, conference, debates, workshop or symposium for free.
 - c) Grant permission(s), provide infrastructural facilities and cooperation to INDGenius in organizing the events/activities in the campus.
 - d) Establish "INDGenius" Clubs/Committee's in all its schools and form a student led committee with students and faculty of university only after consultation with INDGenius.
 - e) Allow, permit and encourage students and faculties to positively participate as well as take part in organizing the events/activities to be undertaken by INDGenius.
 - f) Jointly organise a two-day residential programme for students of premiere institutes.
 - g) Conduct a two-day residential programme and workshop of selected students from The ICFAI University, Sikkim to create awareness on issues of national and international importance.
 - h) Jointly establish a centre for Indic Studies in the university premises.
 - Designate the campus as the "INDGenius Campus", small step towards promotion of Indian educational institutions to foreign students on all its social media platforms and websites.
